

COVID-19 Parent Agreement 2021

- I will drop off my child at the studio door no more than 5 minutes before the scheduled start. I understand that the corridor is a common area used by other businesses and cannot be used as a waiting area.
- I agree that my child will adhere to the rules of the studio.
- I understand that no parents are allowed to enter the studio during class times for observation. If I need to speak to a staff member I will make an appointment via email, or email/call.
- If I will be late collecting my child I will ring the studio to let staff know.
- My child will be required to hand sanitise upon entry and exit.
- My child will support the social distancing rules.
- My child will arrive in the correct attire ready for dance. Please note that the change room will be closed.
- I understand that lost property may not be kept for longer than a week. I will label my child's belongings and contact the office promptly if they leave something behind.
- My child will bring their own named drinking bottle to class.
- I agree to keep my child home if they or anyone in my family is coughing, has a temperature, runny nose or other COVID 19 symptoms. I understand and agree that these procedures will change and evolve over time and that I will follow any new standards required by the Victorian Government and Dance Plus Studios.
- I understand that the teachers and everyone at the studio will make a strong effort to maintain social distancing but that there will be times when incidental contact and less than 1.5m physical distancing may occur. I am aware and agree that spotting is an essential part of training in acro classes in order to keep students safe and prevent injury. I will allow my child to be spotted when it is necessary.
